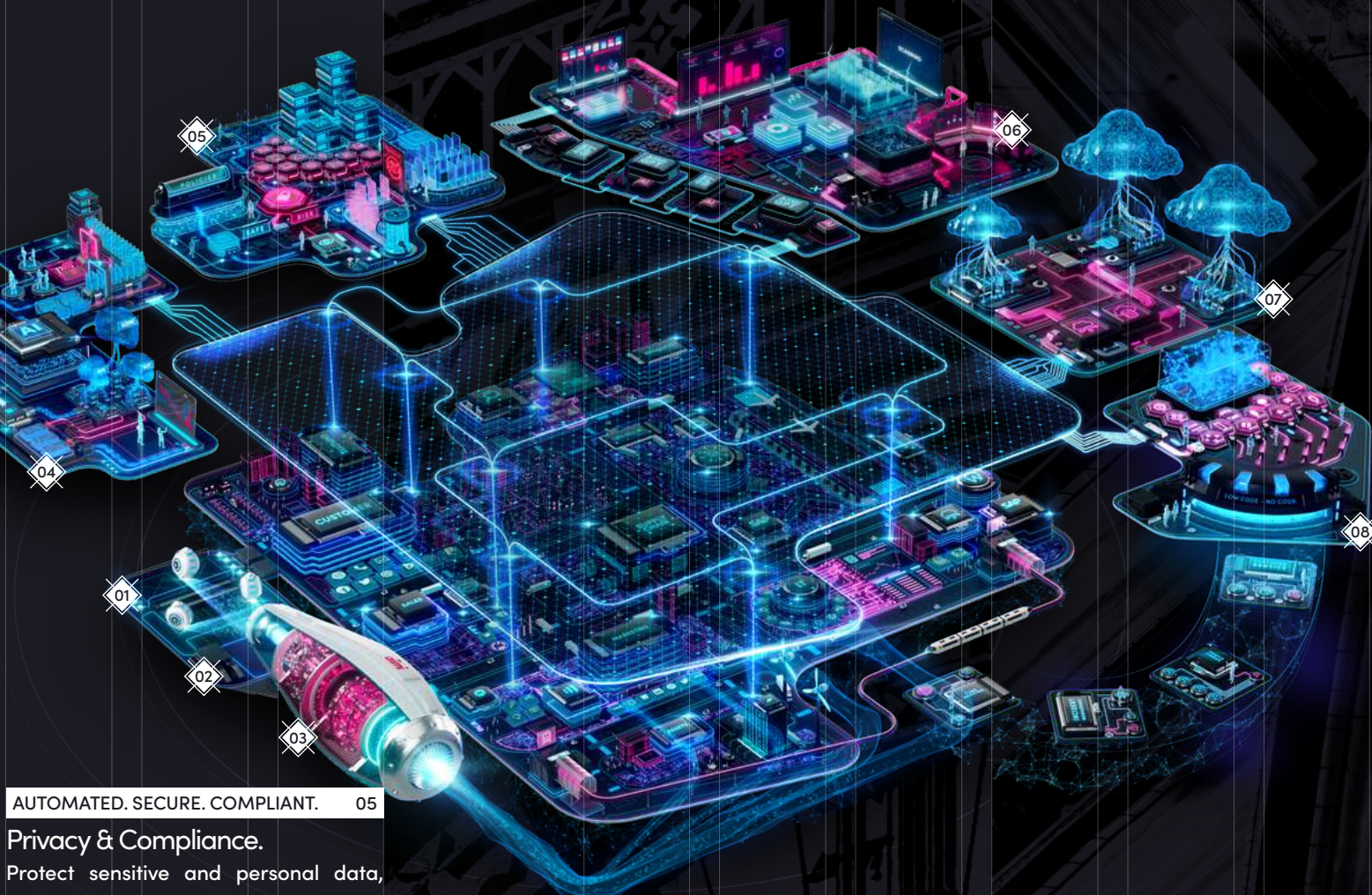

### Financial Conduct Authority.
